#### **CURRENT ECONOMIC AND POLITICAL ISSUES**

- Pakistan continues to face multiple sources of internal and external conflict. Extremism and intolerance of diversity and dissent have grown, fuelled by a narrow vision of Pakistan's national identity, and are threatening the country's prospects for social cohesion and stability.
- ❖ The inability of state institutions to reliably provide peaceful ways to resolve grievances has encouraged groups to seek violence as an alternative. The country saw peaceful political transitions after the 2013 and 2018 elections. However, as the country prepares for anticipated elections in 2024, it continues to face a fragile economy along with deepening domestic polarization. Meanwhile, devastating flooding across Pakistan in 2022 has caused billions in damage, strained the country's agriculture and health sectors, and also laid bare Pakistan's vulnerability to climate disasters and troubling weaknesses in governance and economic stability.
- Regionally, Pakistan faces a resurgence of extremist groups along its border with Afghanistan, which has raised tensions with Taliban-led Afghanistan. Despite a declared ceasefire on the Line of Control in Kashmir in 2021, relations with India remain stagnant and vulnerable to crises that

pose a threat to regional and international security. The presence and influence of China, as a great power and close ally of Pakistan, has both the potential to ameliorate and exacerbate various internal and external conflicts in the region.

- There is some recognition by the state that instead of merely kinetic responses holistic counterterrorism policies are needed to counteract this trend. The growing extremism has been fueled by a narrow vision of Pakistan's national identity, threatening the country's prospect for social cohesion and stability. The inability of state institutions to reliably provide peaceful ways to resolve grievances has encouraged groups to seek violence as a legitimate alternative.
- ❖ The Pakistani police have struggled with a poor relationship with the public, characterized by mistrust and mistreatment, which has hindered effective policing. USIP has partnered with national and provincial police departments to aid in building police-community relationships and strengthening policing in Pakistan through training, capacity building and social media engagement.
- ❖ Nearly two-thirds of Pakistan's population is under the age of 30. Youth with access to higher education carry disproportionate influence in society. However, Pakistan's siloed education system does not allow interactions across diverse groups or campuses, leading to intolerance, and in some cases, radicalization. To tackle growing intolerance of diversity on university campuses, USIP has partnered with civil society and state institutions to support programs that establish sustainable mechanisms for dialogue, critical thinking and peace education.
- Torrential rains have ravaged more than 72% of Pakistan. More than 5,100 people have lost their lives. Schools, crops, livestock, and homes have been destroyed, leaving women and their families in urgent need of temporary shelter and financial assistance. In the wake of natural disasters, there is also an increased risk of violence against women.
- Pakistan continues to reel from uncertainty as its political transition ill-timed during a period of domestic and global economic tumult — has yet to consolidate.
- ❖ Political volatility during the new governing coalition's first two months in power has led to policy paralysis. But this paralysis has begun to ease as the army has signaled support for the government and the International Monetary Fund (IMF) continues to press for austerity measures.
- ❖ These measures will ease Pakistan's twin deficit challenge, involving both fiscal and current account deficits, but they will also take a heavy toll on the average Pakistani. Inflation, which hit 29.8% in May, could rise to around 20% and remain in the double digits into next year. This will be a painful summer for Pakistanis as they're hit with a one-two punch of rising energy prices and electricity supply cuts.

Director-General, who also holds the role of Advisor to the Prime Minister, to discuss matters related to the Merchant Marine Policy. During their meeting, they extended an invitation for him to attend the upcoming AGM lunch and share his insights and opinions on various matters.

- ❖ ②Liaison with Port Qasim Authority/Karachi Port Trust Chairman for resolving port related issues.
- ❖ Meeting held with KPT regarding KPT Safety by Laws on 3-11-2023 in KPT Head office with Manager Port Safety.
- Letter issued to Collector and Additional Collector Customs dated to highlight issues faced by members due to entry of empty containers in to terminals electronically.
- ❖ Detailed proposal sent to Customs along with comments and rationale for amending Shipping Agents Rules in line with SRO 1220(I)/2015 dated 04.12.2015 again.
- ❖ Letter sent to Assistant Collector (Licensing) and explaining the position of Members in lieu of Freight Charges while reiterating that commercial matters may not be dictated by Customs Authority in line of the guidelines from Competition Commission of Pakistan.
- Meeting held at Custom house regarding phyto sanitary Certificate which was attended by Plant Protection department.
- ❖ Meeting with ADC Customs and officials to address the concerns of shipping lines due to fine/penalty on containers which are delayed due to auction/destruction of cargo.
- Meeting with Collector Preventive Customs and officials to stress that the inventories should not be struck in any process and smooth running to be maintained and to grant extension for entry for empty containers in terminal electronically.
- ❖ Letter issued to Assistant Chief, Ministry of Commerce to clarify the position on shortage of containers and the support provided by its Members to the industry at large.
- ❖ Meeting request sent to SBP to discuss regarding the progress and transactions of Electronic Bill of Lading which was due to be completed in the coming months.
- Various meetings held by Members with Customs official regarding stuck-up containers of shipping lines at the terminals and support from lines in order to facilitate and assist release of containers.
- Meeting with DG Transit Trade and Commercial Attaché' and stake holders to promote trade between Pakistan and Afghanistan and to resolve the issues with traders.
- ❖ Meeting held with senior management of Pakistan Single Window on bridging legal gaps in the development of Port Community System.

- Meeting with Chief Collector MCC Appraisement & Facilitation to discuss matters of mutual interest.
- ❖ Follow up of Letter dated 21.07.2022 sent to Acting Governor and Deputy Governor State Bank of Pakistan regarding delay in approval for Freight and Detention Remittances of APSA members, while further requesting appropriate measures to be taken to avoid blocking of foreign funds.
- Letter received from Port Health regarding the provision of ship manifest of Cargo deceleration and for the implementation of port Health rules.
- ❖ APSA along with member shipping lines had a meeting with State Bank of Pakistan top officials to discuss the pending issues facing by lines for the remittances on October 31, 2023. The meeting were coordinated by Meezan Bank Limited . The senior management of Meezan Bank Limited were called ONLINE for further briefing on meeting with State bank of Pakistan.
- ❖ The MBL team and APSA secretariat have already shared the minutes of the meeting after the consent of the State bank of Pakistan and seeking State bank of Pakistan confirmation in writing for the finalization of matters specially the sub bank account to be used for container detention.
- Mr. Salah Uddin has informed members that the meeting ended on a positive note and appreciates the shipping lines to join hands. He also appreciated the role of MBL in arranging the meeting.
- ❖ Committee members of APSA representing SBP matters suggested continuing dialogue with the SBP officials and suggested that APSA should on a regular basis engage with SBP official to resolve the matters of the shipping industry. It is also emphasized that Electronic Bill of lading matter to be resolved as a priority, MBL senior management also assured the EC of their full support.
- Chairman had also advised that APSA should have a follow-up meeting with State Bank of Pakistan and encourage continuing coordination with the SBP officials. He also advised that PSW ONLINE system for shipping line to be started soon and to be followed up.
- Secretary General informed that a training session is arranged in collaboration with PSW management. He also apprises EC members that the initial response was very slow but now over 65 participants are registered through ONLINE link prepared by PSW.
- The matter of stolen containers cases has been discussed. Secretary General also informed that one of the shipping line containers had been stolen recently and FIR is lodged for the recovery by the shipping lines.
- It was requested to all members to send their similar cases details so meeting with transporter or Empty yards can be arranged.

- Chairmen asked all EC members to share stolen container cases and other details. He further emphasizes sending the details of various mishap or fraud so proper presentation can be prepared by APSA.
- APSA also arrange a workshop on how to protect shipping lines from fraud and operational flaws. Chairman asked Secretary General to make necessary preparations.
- ❖ The APSA secretary has been asked to arrange meeting with DG Afghan Transit Trade to discuss matters facing by members for Afghan transit trade. The secretary will inform the date of the meeting to the members after the appointment.
- The Secretary General had briefed the stuck-up container due to Auction and Destruction asked members to share the details of containers for further follow up with the respective authorities and Terminals. A chairman has informed that he and APSA should meet Collector SAPT and Chief Collector on subject matter. Chairman asked EC members to check before giving the container who has just released from auction. It was mention in the meeting with Collector preventive and enforcement to resolve GD hold issue and advised EC members to utilize the auction container after sorting the GDs issue.
- ❖ Effective liaison with Provincial Revenue Boards of all Provinces to safe guard the interest of members.
- Escalate proposals and suggestions to Government of Pakistan for Federal Budget, Trade Policies & etc.
- ❖ To achieve representation in the National Shipping Board of Pakistan enshrined in the Prime Minister of Pakistan's Vision.
- Liaison with Foreign Diplomatic Missions in Pakistan and Pakistan Foreign/Trade Missions abroad to exchange information and promotion of shipping industry activities.
